## **President:**

Introductions of board and 2017 Recap

- Association is in good financial standing
- Capital Improvements
  - RR 620 Improvements
    - Front island and sign removed
  - Playscape improvement
  - Pergola improvement
  - Bridge improvement
  - Security Cameras
  - 911 emergency phone
  - Amenity Center upkeep and updates
  - Repairs to association irrigation systems
  - Pool deck repairs pending
  - Parking is being enforced
  - Renters must send lease agreements to GMI

#### Treasurer:

- Association balance is up from ~\$308,000 to ~\$316,000 in the past year, however a
  pending payment of \$47,038.08 for capital improvements to playscape is still pending,
  so effective balance is down moderately.
  - In good financial standing
  - An audit is currently underway

#### Landscape:

- The Oaklands is coming up on its 25<sup>th</sup> anniversary
  - Lots of dead and dying trees that need to be addresses
  - The arroyos are being taken care of one at a time

#### **NEC Committee:**

- Playscape improvements
  - New playscape installed
  - Slab, stumps, and old trash cans removed
  - Looking for volunteers for the NEC Committee
- Pergola Swing pending installation per board's decision
- Chain swings to be installed this week

## Social:

Currently looking for a social committee chair member

#### **Board Member Election:**

- Board clarified that all elected members serve for 2 year terms
- The CCRs allow for up to 10 board members to serve
- Nominations from the floor
  - None received
- 6 candidates were listed on the ballot and introduced
  - New: Brad Harwick, Emily Cannon, Janise Page, Peter Walz
  - o Returning: John Parrella and Andrew Robertson
- All members were elected unanimously to the board by a show of hand
- There are now 7 members on the board with Mark serving for 1 more year

## **Management Update:**

- Review of balance sheet and income vs expenses for 2017
  - Association balance is up from ~\$308,000 to ~\$316,000 in the past year, however a pending payment of \$47,038.08 for capital improvements to playscape is still pending, so effective balance is down moderately.
- Goodwin Management services overview
  - o Restriction enforcement
  - Parking in the street

#### **Old Business:**

- Residents were giving the opportunity to voice questions and concerns
  - o Mentions of periodic wildlife infestations and what can be done about it
  - Questions were asked about how to make amendments to the CCRs
  - o 2/3 of voting members or a majority vote at the annual meeting is needed
  - The board is already working on amendments for the CCRs
  - o Concerns about the number of cars allowed in the garage and driveway
  - Trees dying and being removed from several places in the community
