THIS FIRST SUPPLEMENT TO NOTICE OF FILING OF DEDICATORY INSTRUMENTS FOR CANDLE MEADOW (this "First Supplement") is made this 27 day of March, 2012, by Candle Meadow Homeowners Association (the "Association").

WITNESSETH:

WHEREAS, CMD, Ltd. ("Declarant") prepared and recorded an instrument entitled "Declaration of Candle Meadow, City of DeSoto, Dallas County, Texas" on June 21, 2001, at Volume 2001121, Page 03563 *et seq.* of the Deed Records of Dallas County, Texas, as amended and supplemented (the "Declaration"); and

WHEREAS, the Association is the property owners' association created by the Declarant to manage or regulate the planned unit development covered by the Declaration, which regime is more particularly described in the Declaration; and

WHEREAS, Section 202.006 of the Texas Property Code provides that a property owners' association must file each dedicatory instrument governing the association in the real property records of the county in which the development is located; and

WHEREAS, on or about the 20th day of August, 2007, the Association filed a Notice of Filing of Dedicatory Instruments as Document No. 20070301088 of the Real Property Records, Dallas County, Texas (the "Notice"); and

WHEREAS, the Association desires to supplement the Notice to record the Second Amendment to Bylaws in the Real Property Records of Dallas County, Texas, pursuant to and in accordance with Section 202.006 of the Texas Property Code.

NOW, THEREFORE, the dedicatory instrument attached hereto as **Exhibit "A"** is a true and correct copy of the original and is hereby filed of record in the Real Property Records of Dallas County, Texas, in accordance with the requirements of Section 202.006 of the Texas Property Code.

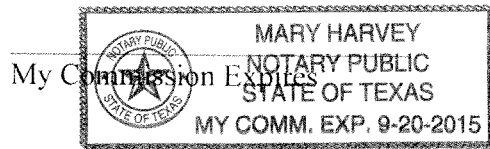
